Subject : Appeal to reconsider decision to allow Bhai Sukha Singh UK to do Katha

The Malaysian Gurdwaras Council and The Khalsa Diwan Malaysia are jointly appealing to your goodness to reconsider your decision to allow Bhai Sukha Singh UK to do Katha from 5th to 8th April at Tat Khalsa Diwan Selangor.

Many messages have been received by us from all over the country imploring us to intervene and advise SNSM against allowing Bhai Sukha Singh to do the scheduled Katha.

Bhai Sukha Singh UK is wellknown for the following transgressions of the Sikh Maryada:

- (i) Bhai Sukha Singh does not accept the Panth Sanctioned Sikh Rehet Maryada which stipulates "No book should be installed like and at par with the Guru Granth".
(SRM Pg 11 "ੴ")

The irrefutable facts show that Bhai Sukha Singh has at a Gurdwara in Birmingham placed B.N. (Dasam Granth) on par with our Eternal Guru Sri Guru Granth Sahib Ji and carries out an annual Path of the B.N. (DG) in contravention of the SRM.

- (ii) Bhai Sahib has openly proclaimed the BN (DG) as "Dasam Sri Guru Granth Sahib," thus clearly creating the concept of 2 Gurus, and openly defying the Antham Hukum of Sri Guru Gobind Singh Ji that "Sabh Sikhan Ko Hukam Hai Guru Manio Granth". That Gurtha Gaddhi was only bestowed on Sri Guru Granth Sahib Ji and on no other book.

The Bhai Sahib's above proclamation also openly challenges the Supremacy of the Sri Guru Granth Sahib Ji and as the only spiritual Guru of the Sikhs.

- (iii) Bhai Sahib also regularly conducts “Arti – Aarta” of SGGSJ and the BN (DG) where both are placed on par and side by side, which is a clear violation of the S.R.M. Sikh Gurmat.

Sdr Jathedar Sahib Ji, by putting Bhai Sukha Singh on stage it will be tantamount to endorsing his blasphemous and deviant views. It may also lend credence to his obscene actions as he is the invited speaker of a respectable Sikh Organisation which has a clear track record of service.


